I AGREE to abide by all instructions given to me while participating in the Civilian Ride-Along Program and I ASSUME RESPONSIBILITY for my failure to abide by such instructions.

I AGREE TO INDEMNIFY AND HOLD HARMLESS the Borough of Weatherly from and against any and all liability, loss, cost of expense (including attorney's fees), arising from or in any manner connected with my being permitted to participate in the Civilian Ride-Along Program.

I HAVE READ AND UNDERSTAND THIS AGREEMENT AND BY SIGNING IT I VOLUNTARILY INTEND TO RELEASE AND INDEMNIFY THE BOROUGH OF WEATHERLY FROM MY PARTICIPATION IN THE CIVILIAN RIDE-ALONG PROGRAM.
